President's Statement



The Institute of National Planning was established by Law No. 231 of 1960 as a public institution with independent legal nature, engaged in scientific activities to enhance the approach and concept of scientific planning in Egypt through research, consultancy, training, and educational activities. The INP aims to promote and establish the concept of planning across all national institutions, as well as to disseminate a culture of planning within Egyptian society. In furtherance of its development of the legislative framework, Law No. 13 of 2015 and its executive regulations were issued on December 17, 2016 to keep pace with the latest national, regional and international developments and advancements through a comprehensive reform process.

The Sustainable Development Strategy encapsulates Egypt's Vision 2030 as a fundamental key in the nation's holistic development trajectory, establishing a link between the present and the future. 

The modeling unit focuses on three main activities: training and capacity building in quantitative models, attempting to apply these quantitative models in the research outputs prepared by the unit members, and ensuring collaboration with Arab and international institutes in the fields of joint training and research.

Training Activities:

In line with the goal of enhancing the quantitative capabilities and skills of unit members, the following programs were conducted:

- General Economic Modeling Program in the period: October 9-13, 2022.
- Social Accounting Matrix and General Equilibrium Models Part One in the period: November 13-24, 2022.
- Dynamic General Equilibrium Models in the period: June 5-15, 2023.





Research Activities:

The modeling unit aims to construct a standard model for the Egyptian economy. In this regard, the following has been accomplished:

• Completion of the first phase of building this model, with the main output being the estimation of four demand-related functions (private consumption, private investment, exports, and imports), currently under review in the Egyptian Journal of Development and Planning.

Ongoing work on other outputs, including:

- Assessing the impact of currency devaluation on the Egyptian economy and households.
- Public investment expenditure and its impact on private investment at the sectoral level in Egypt.
- Ramifications of crises on the Egyptian economy, focusing on potential effects on economic sectors, with a specific focus on the COVID-19 and Ukrainian war crises.
- Potential implications of crises on foreign currency reserves in Egypt, with a focus on the COVID-19 pandemic and the Russo-Ukrainian war.
- Deflation of the Gross Domestic Product: Methodology and Application.

Collaboration with Arab and international institutes in the fields of joint training and research:

The Joint Modeling Unit was established in collaboration with the Arab Planning Institute in Kuwait on January 5, 2023.



The Unit was established at the Institute of National Planning by decision of INP president on November 20, 2023. Members of the unit were selected from various scientific centers within the institute to form a multidisciplinary team in the fields of mathematics, computer science, economics, environment, and social sciences.

Objectives of the unit: The main goal of establishing the unit is to prepare national cadres capable of building and applying simulation models using the System Dynamics methodology to study complex economic, social, and environmental dynamic problems under alternative future scenarios. This aims at supporting policymakers and planning officials at all levels of governance.

The capacity-building project for the members of the unit: The unit is in the process of implementing a project in collaboration with the Millennium Institute in the United States, which will begin in the first quarter of this year and last for two and a half years. The project will go through three main stages to build the capabilities of the Economic Governance Unit members:

First stage: Conducting two training programs, one focused on computer programming with STELLA software and the other on an advanced course in modeling using System Dynamics (note that all unit members have completed a free online introductory course in System Dynamics at the University of Bergen in Norway).


Second stage: Customizing and calibrating the international model for Sustainable Development Goals (SDG) developed by the Millennium Institute for application in the case of Egypt to study alternative future scenarios. Several workshops will be held for discussions and scenarios about the model, in which unit members will participate along with interested parties from within and outside the institute.

Third stage: Training unit members on the integrated model (which includes 10 economic sectors, 10 environmental sectors, and 10 social sectors) and how to operate and develop the model in the future. This includes sectoral training and how to expand or add new sectors to the model to serve scientific activities at the institute

Tasks of the Unit:

- Study and identify complex and dynamic economic and social problems in Egypt through modeling, simulation, analysis, and linking them to governance components.
- Analyze national development policies using System Dynamics methodology and tools.
- Utilize local, regional, and international experiences, and integrate stakeholders' opinions within the framework of economic modeling and governance.
- Develop System Dynamics models and apply them in the national context to assist the government in addressing development challenges and implementing governance.
- Build models to analyze long-term development outcomes and derive different scenarios and alternatives for implementation.
- Build capacities and prepare necessary personnel for designing more effective developmental policies.
- Implement local and international training programs in partnership with specialized international institutions in assessing sustainable development models and governance.
- Issue working papers based on evidence-based policy methodology.
- Propose and evaluate policies to address sustainable development and governance issues and present different alternatives and scenarios.









The North African Applied Systems Analysis Center (NAASAC) project is a result of collaboration between the Institute of National Planning and the Academy of Scientific Research and Technology and the International Institute for Applied Systems Analysis (IIASA) in Austria, established on December 20, 2021. The project was launched on December 20, 2021, in the presence of the Minister of Higher Education and Scientific Research, the President of the Academy of Scientific Research and Technology, the President of the Institute of National Planning, and the Dean of Capacity Building at IIASA. The project aims to build capacities in North Africa in systems thinking and system analysis applications, and to create a culture of evidence-based decision-making and share this culture in the region.

Over the course of two years, the activities of the NAASAC center varied, including capacity building, scientific publishing, and awareness-raising efforts.

Capacity Building Field

The center offered a diploma in System Analysis Applications, which was attended by trainers from Lebanon and Egypt, as well as from IIASA, who provided examples of models they had built to solve some complex problems. In addition to training Egyptians, Palestinians and Sudanese.

The center also conducted a training course on an Introduction to Systems Thinking, and the following activities were carried out:

- Preparation of an intensive scientific material on the topic of Introduction to System Thinking, presented to the scientific staff and assistant scientific staff at the Institute of National Planning, as well as to some of the students of the professional master's program at the institute (May 7, 2023 - May 31, 2023).
- Agreement with the National Council for Women to conduct training for employees in preparing development projects at the council on the topic of System Thinking.

Scientific Publishing Field:

A research paper was published in a prestigious scientific journal titled "Systems" under the title "Decent Life Initiative and Sustainable Development Goals: A Systems Thinking Approach." Additionally, a book titled "Systems Thinking to Support Arab Sustainable Development Policies – in Light of Global Experiences" is in the final stages of publication.

Awareness Field:

The center has conducted numerous awareness-raising seminars on systems thinking for various age groups, ranging from children to postgraduate students.

- NAASAC organized a workshop on Tuesday, February 14, 2023, at the Seventh Cairo International Innovation Exhibition 2023, held in the New Administrative Capital, for 17 children aged 7 to 12 from the University of the Child. The workshop aimed to raise awareness about systems thinking through games and exercises on the topic of the water cycle, and it was presented by a group of young researchers from the Institute of National Planning under the supervision of Prof. Amani El-Reis, the project manager.
- NAASAC organized a seminar on systems thinking for 28 first-year students in the professional master's program "Planning for Sustainable Development" at the Institute of National Planning on April 14, 2023.

International Participations of the Center:

The center participated in numerous international seminars, conferences, and workshops, focusing on the importance of applying systems analysis by showcasing some practical applications. Additionally, introductory presentations about the center were conducted.

- Symposium: "Developing the Next Generation of Systems Analysts," held in South Africa on August 16, 2022, remotely, on the occasion of the fiftieth anniversary of IIASA. Prof. Amani El-Reis presented an overview of the North African Applied Systems Analysis Center (NAASAC).
- The Africa-Europe Science Collaboration and Innovation Platform (AERAP) on November 16, 2022 (attended by Prof. Amani El-Reis remotely).
- World Science Forum (WSF) in Cape Town, South Africa, from December 6 to 9, 2022.
- IIASA Forum, where Prof. Taysir Abu El-Nasr presented the NAASAC's experience.



(1) ISO 45001:2018 Occupational Health and Safety Management Certificate

Certificate Overview:

An international standard for Occupational Health and Safety Management, it enhances the presence of a safe and healthy work environment by providing a framework that allows the organization to identify and monitor risks threatening occupational health and safety in the building. It aims to reduce the likelihood of accidents, assist in compliance with regulations and laws, and improve the overall performance of occupational health and safety in the building.



(2) ISO 14001:2015 Environmental Management Certificate **Certificate Overview:**

An international standard for Environmental Management, the standard aims to help organizations reduce activities that negatively impact the environment and sets controls for those activities. This includes the use of natural resources, handling and treatment of waste, and energy consumption.







Publications:

The INP has been involved in preparing and conducting scientific research and studies covering various aspects of economic, social, and environmental development since its establishment, which are included in an annual plan of the institute. Additionally, there are research and studies executed through contracts with national, regional, or international institutions upon their request. Moreover, there are research and studies initiated by individual staff members of the institute or external entities, which benefit decision-makers, policy-makers, or aid in the preparation or implementation of development plans. Furthermore, there are individual research and studies prepared and conducted as background research for reports issued by the institute or to address specific economic and social issues discussed in conferences, scientific seminars, expert meetings organized by the institute, or prepared for publication in journals inside and outside Egypt.

(1) Planning and Development Issues Series:

The Planning and Development Issues Series is one of the main channels for disseminating the output of the Institute of National Planning in terms of peer-reviewed collective studies and research in various fields of planning and development. INP comprises a diverse and multidisciplinary group of researchers and experts, adding value and utility to such diverse conducted studies. In addition to their comprehensiveness, these studies focus on economic, social, environmental, institutional, informational, and other research areas. The number of publications reached 348 by 2023.

Since its inception in 1977, the various publications of the Planning and Development Issues Series have included a number of studies addressing diverse issues that benefit researchers, students, policymakers, and decision-makers in various fields of planning and development. These studies cover a wide range of topics, including but not limited to:

(2) The Egyptian Journal of Development and Planning:

The Egyptian Journal of Development and Planning is a peer-reviewed quarterly scientific journal published by the Institute of National Planning regularly since 1993. It has obtained the highest rank (7/7) according to the evaluation of the Supreme Council of Universities for Egyptian Local Scientific journals and until 2023, the journal has released 31 volumes. It is considered one of the leading Arab journals specialized in addressing and presenting issues of development and planning in Egypt and the Arab region, in addition to covering global development issues and trends. The journal targets a broad audience, including faculty members, researchers in universities and research institutes, regional and international think tanks, leaders of planning agencies, development management, and public policy makers, as well as development experts, planners, and policymakers. It also supports organizations in the public, private, and joint sectors, civil society organizations, and various international and regional specialized organizations.







(3) Scientific Reports and Research Projects:

For scientific reports and research projects, INP has issued several scientific reports either individually or in partnership with regional and international entities:

Egypt Development Status Report 2022

The report focuses on monitoring and evaluating the developmental performance in Egypt in light of the Sustainable Development Strategy: Egypt Vision 2030. It also provides an analytical overview of this performance compared to other countries worldwide, through indicators from international reports concerned with monitoring development situations globally. Additionally, it tracks and evaluates the economic, social, and environmental policies implemented during the year of interest. The first edition was issued in 2018.



Food Security Status Report 2020:

The institute issued the first report in Egypt in 2017 on the status of food security, aiming to discuss various food security issues and to assist policymakers, decision-makers, researchers, students, and stakeholders interested in food security conditions.



Human Development Report:

The Human Development Report is considered one of the fundamental factors in safeguarding human rights and advancing democracy and equality. Human development means allowing individuals to determine and choose the life they want, with the government supporting them with appropriate tools to determine that. The Human Development Report is issued through the United Nations Development Program (UNDP), which is a global development network affiliated with the United Nations. It is an organization that supports change and connects countries with knowledge, expertise, and resources to help individuals build better lives. Project for Deepening Local Industrialization in Egypt:

INP has undertaken an ambitious project titled "Deepening Local Industrialization in Egypt," which is the result of a three-year research effort. The project began in the summer of 2020 and was launched in the summer of 2023. It is based on 28 papers prepared as part of the project, as well as on discussions held in numerous workshops, seminars, scientific meetings, field visits, and other sources.

This project aimed to achieve the following four objectives:

- Identifying the missing or weak links in the logical chain for transferring industrialization deepening from the realm of thought to the field of application.
- Proposing specific policies and mechanisms to provide the logical chain for deepening industrialization with what is missing from its links and to strengthen what is weak, in order to turn the goal of deepening industrialization into tangible reality. This particularly involves formulating an integrated industrial policy and a policy for research, development, and innovation closely linked to production facilities.
- Identifying nominated industries suitable for deepening based on various criteria and methodologies.
- Identifying what is required to deepen industrialization in some of the industries nominated for deepening. This includes case studies of several industries aimed at exploring their potential for deepening-.





The INP Produced Three Important Reports for the First time:

Sustainability Report:

This report reviews the academic role of the institute since its inception in the first year (2016/2017) following the issuance of the Sustainable Development Strategy Vision Egypt 2030. It also highlights the supporting factors for this performance in terms of social and operational aspects, including environmental aspects. The report briefly addresses financial sustainability and provides proposals for improving performance in some aspects of sustainability at the institute.



Greening INP's Building Report:

This report aims to present a project to transform the institute's building into a green building, outlining its objectives, the approach followed, the stages of work, and the results achieved. At the end, it elucidates the necessary procedures to bring about this change and the proposed action plan for implementing these procedures.



INP Carbon Footprint Report:

INP issued its first report on carbon footprint from 1/7/2021, to 30/6/2022, highlighting the importance of positive participation in reducing annual emissions of greenhouse gases, which are a real threat to all economic, social, and environmental activities.

The institute launched an initiative to write reference books as part of its scientific program for the academic year 2014/2015. As it is known, writing books takes a relatively long time. Therefore, the institute published its first book under this initiative in the academic year 2017/2018. The book, written by Prof. Ahmed Farhat, addressed issues of "Transportation and Development."

The second book was published in the academic year 2018/2019, written by Prof. Ibrahim El-Eissawi, addressing "Renewing Economic Thought - A Critical Look at the Dominant Economic Thought and an Overview and Evaluation of Some Approaches for its Development." The institute released it in collaboration with the Egyptian General Book Authority. The third book was published in 2023 written by Prof. Abd El Hamid Alkasas titled "Fundamentals of Building Mathematical Models and its Applications"



Policy Briefs Series

The policy briefs series covers various fields such as planning, sustainable development, and others as a scientific and practical initiative aimed at studying urgent and critical issues. It assesses their impacts and implications on the Egyptian economy through analyzing different dimensions of the issue under study and proposing policy alternatives to support policymakers and decision-makers.










Scientific Events



These events are held for the purpose of cultural and knowledge exchange, in collaboration with national or international entities, and are held regularly on an annual basis such as INP international conferences, and monthly such as scientific updates, experts' meeting, institute seminars, and young researchers' seminars. Additionally, there are cultural institute salons, distinguished lectures, and several seminars and workshops, all in line with the strategic objectives of the institute and in accordance with its annual academic program.

First: Institute of National Planning Annual International Conferences

Second: Institute of National Planning Seminar

It is a regular meeting held on the third Tuesday of each month with a specific nature every year according to the field of research activities in the same academic year. Experts and specialists in the field of research activities are invited for discussion, and often nonacademics are invited to interact with them and benefit from their executive experiences. Tuesday seminar in the academic year 2022/2023 introduced distinguished sessions dedicated to commemorate the leaders and pioneers of INP.



Pioneers of the Institute of National Planning

Professor Ibrahim Helmi Abdel Rahman,

the founder and first director of the INP, is considered the founding father of planning sciences in Egypt and the Arab world. It is worth mentioning that this eminent scholar was among the first graduates of the Astronomy Department at the first Egyptian Science College at Cairo University. He held numerous positions, serving as the Resident Director of the UNESCO Regional Office for Sciences in Cairo and the first director of the newly established Atomic Energy Authority. He also founded several institutions, including the National Research Center and the Supreme Council of Sciences. He was chosen as a member of the Egyptian delegation to the UNESCO International Conference and served as the head of the Egyptian delegation to the founding conference of the International Atomic Energy Agency in Vienna. He worked as an advisor to the Prime Minister and as the Minister of Planning and Administrative Development.



He also served as an economic advisor to the Arab Fund for Economic and Social Development and to the Organization of Arab Petroleum Exporting Countries (OAPEC) in Kuwait. He was one of the founders of the United Nations Industrial Development Organization (UNIDO) and its first Director-General.


Professor Mohamed Mahmoud El-Emam,

was born in 1924 and passed away on February 11, 2016, at the age of 92. He was a distinguished economist, prominent planner, former Minister of Planning, and one of the founders and directors of the Institute of National Planning.

- He obtained his PhD in Econometrics from the University of Leeds in England in 1957.
- He participated in formulating the First Five-Year Plan "1960-1965".
- Prof. El-Emam was the Minister of Planning in 1976.
- He served as Minister of Planning in 1976 in the third cabinet of Mamdouh Salem.
- He was a member of the National Planning Committee, deputy director of the Central Auditing Organization, a professor at the Institute of National Planning, and its director from 1966 to 1968.
- He served as a consultant to the United Nations for planning affairs in Iraq.
- He participated in formulating the First Five-Year Plan (1960-1965) in the period when Mr. Ali Sabri was the minister, which was one of the most successful development plans in Egypt and achieved unprecedented growth rates according to international economic and monetary institutions in the 1960s.



has written numerous economic books, including "Experiences of Global Integration and Their Implications for Arab Integration," published by the Center for Arab Unity Studies. In this book, he advocated for the development of a project to enhance integration in the Arab world, drawing from various regional experiences and the characteristics of the Arab experience. Prof. Imam remained committed to delivering economic lectures at local, Arab, and regional forums and conferences, as well as writing weekly articles for "Al-Shorouk" newspaper. He has written more than 307 research papers and articles covering various branches.



He is considered one of the most prominent economists in Egypt and a pioneer of economic thought. This think tank emphasizes the alignment between individual rights and societal rights to achieve economic development and human advancement, relying on national self-reliance in utilizing capabilities and resources to avoid all forms of dependency. His studies have focused on uplifting the poor in Egypt and Africa. In this context, he chaired the Third World Forum, from which emerged significant studies on Egyptian society in various fields. Additionally, he led a group of prominent Egyptian researchers and thinkers to develop a scientific vision for Egypt in 2020, exploring future visions for Egypt and how to address challenges domestically.

Professor Kamal Al Ganzouri

(January 12, 1933 - March 31, 2021) was an Egyptian politician who previously served as the Prime Minister of Egypt. He was tasked by the Supreme Council of the Armed Forces with forming the government on November 25, 2011. Prior to that, he had held the position of Prime Minister from January 4, 1996, to October 5, 1999. He owns the idea of the Twenty-Year Plan, which began in 1983 and ended in 2003, marking Egypt's transition after three of the Five-year plans. He was titled "the Minister of the Poor" and "the Opposition Minister" due to his advocacy for low-income individuals during his occupation as Prime Minister and his focus on their welfare.







Third: Institute of National Planning Salon

The Institute of National Planning Salon is one of the important events launched by the institute in May 2022 with the aim of bringing together a selected group of prominent experts and thinkers to discuss the current challenges and urgent issues facing Egypt, the Arab region, and the world, and ways to address them politically, economically, and socially.

The salon serves as an important platform for exchanging views between decision-makers and experts from various fields, with the aim of shaping common visions on how to face challenges and achieve comprehensive and sustainable development in Egypt. The salon is held regularly throughout the academic year at INP, with each session dedicated to a specific theme around which discussions revolve to provide practical insights and solutions. Among the prominent topics recently discussed in the salon are international and regional changes and Egyptian interests, how to achieve sustainable economic growth amid complex challenges, etc. Through its discussions and dialogues, the salon seeks to formulate effective development policies and programs that fulfill the aspirations of the Egyptian people for decent living, stability, and prosperity. Four: Scientific Follow-ups

It is a monthly meeting where the most important updates from international reports, books, and recent research are presented through a critical perspective within the scope of each center. For example, the latest episodes of the scientific follow-ups activity discussed the "2022 State of Finance for Nature" report issued by the United Nations Environment Program, and the "World Economic Outlook October 2023" report. Also, a presentation of the book "How to Achieve Inclusive Growth for All" published by the International Monetary Fund in 2022 was made.



Fifth: Experts' Meeting

It is a meeting where urgent and interconnected issues on the national scene are discussed, and specialized experts in the field are invited to participate in the discussion. For example, sessions during the academic year 2023/2024 included discussions on the anticipated gains and challenges of Egypt's accession to the BRICS group, and discussions on credit rating and financing.



Sixth: Young Researchers' Seminar

It is a meeting where a researcher, often a lecturer or an associate professor, presents a specific topic directed by their center. The researcher is trained to present and discuss the topic and exchange experiences with older generations at the institute. This year, in 2023/2024, the seminar focused on presenting policy briefs to decision-makers, derived from scientific researches by the paper presenters.



Seventh: Distinguished Lecture Series

The Distinguished Lecture Series is one of the important events launched by INP in January 2023 with the aim of presenting and discussing important issues and topics facing the world. It serves as a window for communication with international experts and thinkers from various disciplines and global think tanks to discuss common perspectives on global issues, while providing valuable lessons learned. The institutional framework of the INP has been developed to enhance its role as a center for scientific think tank through the issuance of Law No. (13) of 2015, granting it academic degrees (Diploma, Master's, and Doctorate) independently or in collaboration with universities and research centers domestically and internationally. In this context, INP offers three accredited postgraduate degrees endorsed by the Supreme Council of Universities. Two of them are professional programs, and one is an academic one.

First: Professional Master's Degree in Sustainable Development Planning

- 1. The work on this Master's degree started during the academic year 2018/2019.
- 2. The Professional Master's Degree in Sustainable Development Planning aims to familiarize students with the skills of preparing, monitoring, and evaluating plans, taking into account the objectives of sustainable development.

The program enables students to:

- Prepare the strategic plan and executive work programs within the framework of achieving sustainable development goals.
- Prepare budgets for plan implementation.
- Prepare feasibility studies and project evaluations.
- Prepare indicators for monitoring the plan within the framework of achieving sustainable development goals.
- Evaluate the plan.
- Prepare applied research in the field of sustainable development planning.

Second: Professional Master's Program in Monitoring and Evaluation

The proposed Professional Master's Program in Monitoring and Evaluation is among the pioneering programs offered in Egypt and the Arab region. It is one of the programs that clearly reflects the approach of interconnection and integration between various scientific disciplines. The Professional Master's Program in Monitoring and Evaluation is essential for individuals, institutions, and governments because it enables its graduates to monitor and evaluate the progress of projects, programs, plans, and policies in terms of outputs, outcomes, and expected impacts for each, according to the set plans and timeframes for implementation.

It is worth noting that the Professional Master's Program in Monitoring and Evaluation has been designed to produce graduates who possess the knowledge and skills sought by stakeholders from all beneficiaries of the program. The program will commence during the academic year 2023/2024.

The program enables students to:

- Understand and comprehend the processes of monitoring and evaluation.
- Recognize when and how specific tools and methods are used for monitoring and evaluation.
- Plan, execute, and manage the monitoring and evaluation process.
- Acquire the latest knowledge, skills, and competencies related to project, policy, and program evaluation to ensure the attainment of the best expected results.
- Monitor and evaluate projects/programs/policies.
- Prepare and develop monitoring and evaluation reports.
- Overcome barriers to effective monitoring and evaluation.

Third: Academic Master's Program in Planning and Development

The implementation of the Master's program started in the academic year 2008/2009 with the aim of preparing distinguished cadres in the field of planning and development, qualified to deal with international and local changes in their organizations, whether governmental or non-governmental, with the goal of developing and improving their efficiency and effectiveness. This is achieved through providing an innovative educational and training environment that blends scientific knowledge, practical experiences, and future-oriented vision to achieve excellence.

Thirteen batches have graduated, totaling 139 graduates since the inception of the Master's program until now. The numbers are illustrated in the following table:

The specialized training programs and professional diplomas are implemented for employees working in ministries, the government sector, private sector, and other fields such as planning and development. The institute contracts with numerous local and international organizations to enhance the skills and expertise of employees in these sectors through training programs on specific topics requested by these entities. Additionally, many programs are implemented in collaboration with international organizations such as UNDP, UNICEF, ESCWA, FAO, the Islamic Development Bank, USAID, KDI, and others. Moreover, this activity extends to include some Arab and African countries.



Consultancies

Providing consultancy services to decision-makers, international organizations, academic institutions, the private sector, and civil society both inside and outside Egypt is one of the most important roles of the National Planning Institute. The institute has succeeded in providing the necessary consultancies to United Nations organizations such as the United Nations Development Program (UNDP), the International Organization for Migration (IOM), the Food and Agriculture Organization (FAO), the International Labor Organization (ILO), and the Economic and Social Commission for Western Asia (ESCWA).

Scientific academies also have a significant share in the scientific consultancies provided by the institute. For example, the International Institute for Development Economics and the United Nations University, as well as the International Peace Research Association, benefit from the institute's scientific consultancy services. Additionally, international scholarships agencies such as USAID, AfDB, and Fredrich Naumen have benefited from the institute's consultancy services. Furthermore, decision-makers outside Egypt in the Arab world, such as Saudi Arabia, Kuwait, Qatar, Syria, Palestine, and Lebanon, have also received consultancy services from the institute. The institute has provided consultancy services to some civil society organizations inside and outside Egypt to enable them to develop their services in this context. This guide outlines the main areas of consultancy services provided by the National Planning Institute, highlighting its relative advantage in encompassing multiple specialties that can be utilized across various fields.

INP provides consultancies based on the requests of many national institutions within the framework of contractual agreements between them. For example, the Ministry of Planning, the Energy Planning Agency, the Consultancy Office for Integrated Development, the Building and Development Agency for Egyptian Villages, the Academy of Scientific Research, the Ministry of Public Business Sector, the Experimental Center for Evaluating Social Projects, Asyut Mills Company, Minya Mills Company, the General Authority for Reclamation and Agricultural Development Projects, the Social Development Fund, the Environmental Affairs Agency, the Ministry of Local Development, and the Ministry of Irrigation and Water Resources.

Additionally, there are research and studies being conducted based on requests from regional and international external institutions. These include, for example, the United Nations Development Program, the World Food Program, the United Nations Economic and Social Commission for Western Asia (ESCWA), the World Bank, the Food and Agriculture Organization of the United Nations (FAO), the United Nations Industrial Development Organization (UNIDO), the International Labor Organization (ILO), the German Agency for Technical Cooperation (GTZ).
